Qualifications

According to § 89C-5. Board members; qualifications.

Each land surveyor member of the Board shall be a resident of North Carolina and shall be a licensed professional land surveyor engaged in the lawful practice of land surveying in North Carolina for at least six years.

Meetings: 7 One-Day Meetings Per Year in Raleigh, 7 Surveying Committee Meetings Per Year in Raleigh, 1 Off-Site Meeting Per Year, 2 National Meetings Per Year (Regional - 3 days in April & National – 3 days in August), 5 one-day Disciplinary Committee meetings in Raleigh. NCEES committee participation is voluntary (3-5 days per year).

Homework: Review cases (2-7 hours per week). Board meeting prep. Committee meeting prep.

Compensation: \$100 per day of Board activity. Expenses are reimbursed at actual cost.
